- (A) That the Board of Supervisors approve acceptance of a grant awarding of \$14,000 from First 5 of Santa Barbara County to the County of Santa Barbara Department of Social Services (DSS) for FY 2008-09 to fund the Cuyama Valley Family Resource Center Early Childhood Enrichment Services Program, and the related contract between DSS and First 5 signed June 25, 2008.
- (B) That the Board of Supervisors approve a Budget Revision Request increasing the budget for DSS by \$14,000 for FY 2008-09.

Summary Text:

On May 19, 2008 First Five awarded a grant to DSS to fund the Cuyama Valley Family Resource Center Early Childhood Enrichment Services Program. This program provides early childhood enrichment services at the Cuyama Valley Family Resources Center. The program will provide: (a) quality child development and enriching activities for children ages 0-5 whose parents are using the center's services; and/or (b) capacity-building for community members interested in obtaining skills in early childhood development. Formal participants in the capacity-building program will be given an opportunity to help teach parenting classes, assist in the Mommy & Me program, help develop the Post-Partum Support Group, and practice their skills by taking turns providing child-development activities while parents are in classes. The program may provide support for at least two adults to attend Early Childhood Education courses at Taft College.

Narrative:

The funding for this grant was approved on May 19, 2008, and the corresponding contract was signed by DSS June 25, 2008, after DSS provided its budget submission to the Chief Executive Office, and so was not included in the FY 2008-09 budget. The grant provides \$14,000 (\$7,000 in line item account 7732 and \$7,000 in line item account 7740) that will be spent on training and age-appropriate materials for children ages 0-5 years. DSS will provide \$2,984 in matching funds currently included in the FY 2008-09 as salaries and benefits.
