Dear Chair Williams and Board of Supervisors:

The Agricultural Advisory Committee (AAC) discussed the referenced project at our regularly scheduled meetings on August 10 and September 14, 2023. After extensive discussion, the AAC voted unanimously to submit the following comments to you regarding several important agricultural issues:

# **Harmful Precedent in Determination Process**

The AAC is concerned that the Planning Commission found for denial, despite the fact that the Zoning Administrator approved the project with the CEQA Mitigated Negative Declaration, including a determination that with mitigation, the project's water use impacts would be reduced to a less than significant level.

Furthermore, Planning and Development Staff recommended approval and found the project to be consistent with County development standards and requirements.

The AAC believes that the finding process did not follow established standards and that the determination by the County Planning Commission was in error. It is of utmost importance to agriculturalists that decision makers follow established standards in making their determinations, so that the large investments that are required to conduct business can be made with confidence as to how various issues will be addressed. Therefore, our concern is not just with the conclusion drawn, but also with the process used to reach that conclusion.

## Sustainable Groundwater Management Act (SGMA) and Water Rights issues

The AAC is concerned with the County using land use authority to make water rights and use determinations in lieu of the local Groundwater Sustainability Agency (GSA) and Water District. The Groundwater Basin status and associated water rights are SGMA issues that should be referred to the local GSA and Water District.

In summary, the AAC is concerned with what it believes are procedural problems evident in how this decision was made, and ultimate findings by the Planning Commission that may set a harmful precedent and could negatively affect agricultural producers and landowners in the future.
