The following activity is determined to be exempt from further environmental review requirements of the California Environmental Quality Act (CEQA) of 1970, as defined in the State and County Guidelines for the implementation of CEQA.

PROJECT DESCRIPTION: County vacation of an easement interest in a portion of Airox Road across APNs 113-250-002 and 113-250-018 as shown on the attached map. The purpose of vacating the Airox Road right-of-way ("ROW") is to remove the County's interest in and liability for unused and unneeded County ROW, and to allow the property owner and applicant to remove this encumbrance from title to their property.

The vacation of the County's ROW will not in and of itself result in any changes to the land.
