#### **Recommended Actions:**

On September 13, 2011, set a hearing for October 11, 2011 to consider the Nelson (agent for applicant) Appeal of the conditions of approval in the Zoning Administrator's approval of 09COC-00000-00003 (11APL-00000-00011); Assessor Parcel Nos. 131-090-076 and a portion of -078 (one of six appeals filed separately for individual Conditional Certificate of Compliance involving approximately 860 contiguous acres). The project site is located approximately ½ mile southeast of the intersection of Tepusquet Road and an existing unnamed jeep road, in the Tepusquet area, Fifth Supervisorial District.

On October 11, 2011, your Board's action should include the following:

- 1. Make the required findings for the project, including CEQA findings;
- 2. Determine the project is exempt pursuant to Section 15061(b)(3) of CEQA, included as Attachment B;
- 3. Approve the project subject to the Conditions of Approval in Attachment C; and
- 4. Deny the appeal; and
