Recommended Actions:

Approve and authorize attached contract with law firm of Goldfarb Lipman to defend County of Santa Barbara in litigation threatened by California Rural Legal Assistance, Inc. challenging the County's Housing Element.

Summary Text:

Under Government Code section 31000, the Board of Supervisors is authorized to contract for special legal services. Due to the specialized nature of the litigation and the reduced staffing in County Counsel, it is most efficient to contract with Goldfarb Lipman, a firm with prior experience with Housing Element litigation. The attached contract is limited to \$150,000.

Background:

On February 19, 2009, California Rural Legal Assistance, Inc. (CRLA) notified the County of Santa Barbara of its claim that the County's Housing Element does not substantially comply with State Housing Element law. This letter constitutes a 60-day notice pursuant to Government Code section 65009, subdivision (d), after which CRLA may sue the County.

In anticipation of this litigation, County Counsel has interviewed outside counsel and recommends Goldfarb Lipman because of their expertise in Housing Element law. The County Executive Office has indicated that the Litigation Designation is intended for the purpose of covering the proposed contract and has sufficient funds available to cover this proposed contract's "not to exceed" amount of \$150,000.

Payment for legal services shall be made upon the contractor's satisfactory performance, based on the scope and methodology contained in Exhibit A of the contract as determined by County staff.
