Executive Summary and Discussion:

This project was constructed to mitigate against future erosion of the slope and reduce the energy of dislodged boulders and materials from the overly steep hillside. The project consisted of the installation of a cable mesh drapery system along the exposed slope to reduce the danger of additional rockfall on the traveling public and nearby residents.

The Director of Public Works accepted this project as complete on January 24, 2006. The project was completed on time and on budget.
