That the Board of Directors of the Santa Barbara County Water Agency accepts a <u>Grant of Easement</u> from Harris Grade Limited Partnership, a California Limited Partnership, owners of Santa Barbara County Assessor parcel numbers 097-250-47-00-6,097-250-47-00-4,097-250-00-2, by authorizing the Clerk of the Board to sign the Certificates of Acceptance attached to the easement. (Clerk, Four-fifths vote required). This easement is located on Harris Grade Road just north of Highway 1 and Purisma Road in the Lompoc area.

## **Executive Summary and Discussion:**

Santa Barbara County Water Agency monitors approximately 275 groundwater wells throughout the County to gather groundwater levels for the determination of groundwater basin status as well as specific projects which require depth to groundwater information. An observation well on the above described real property was destroyed when the property was recently developed by Harris Grade Limited Partnership. The Partnership has produced a replacement observation well solely at its cost and acceptance of the Grant of Easement simply provides future guarantee of access to Water Agency staff in order to make periodical measurements.
