Fourth Amendment to Agreement


**AMENDMENT NO. 4 TO LAC EXTERNAL ENTITY AGREEMENT DATED MAY 15, 2018
BETWEEN
PICTOMETRY INTERNATIONAL CORP. AND COUNTY OF SANTA BARBARA, CA**

1. 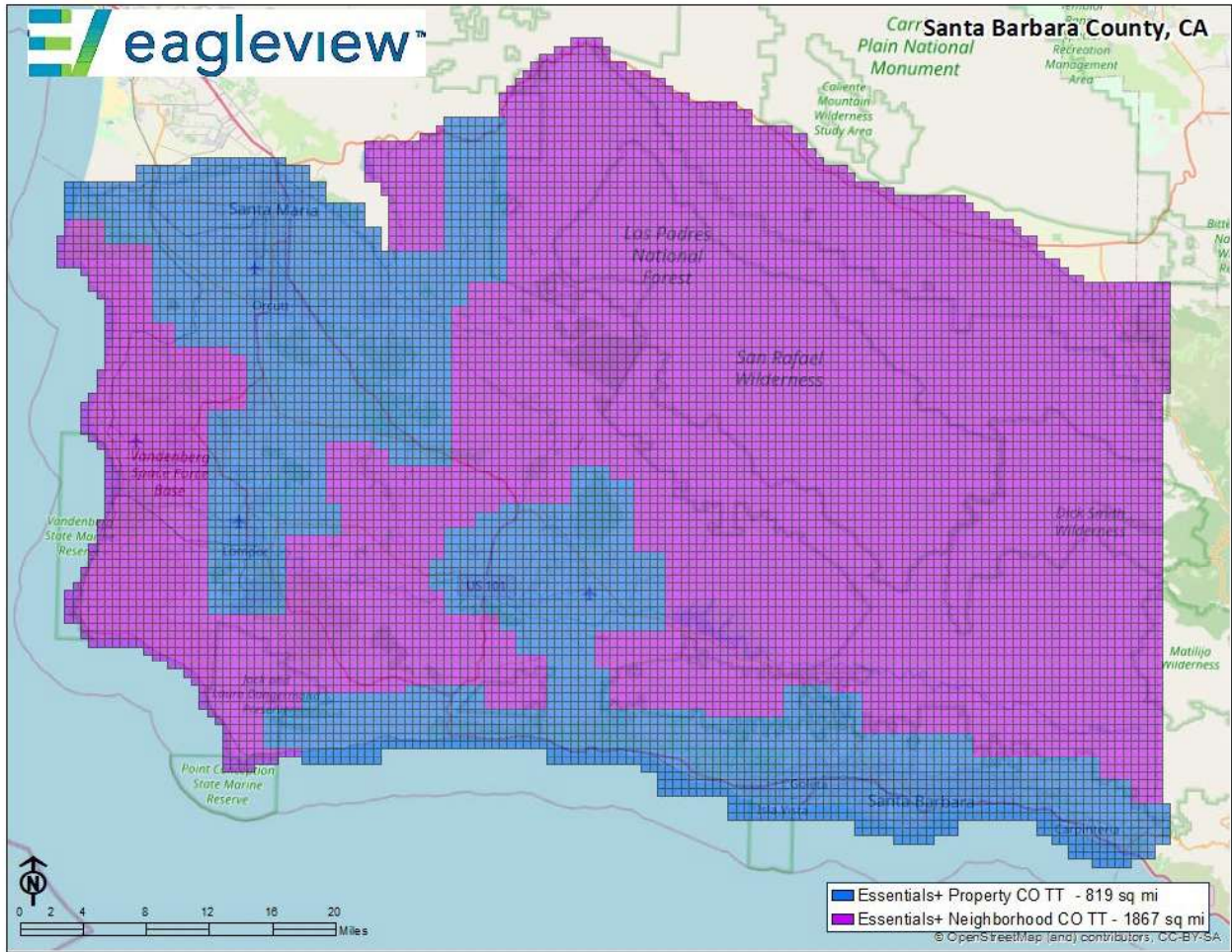
