SUBJECT: County Service Area No. 41, Cebada Canyon
Fourth Supervisorial District for Fiscal Year 2004-2005

Recommendation(s):

That the Board of Supervisors:

- A. Adopt the attached Resolution establishing road maintenance charges for County Service Area No.41.
- B. Approve Public Works Notice of Exemption pursuant to County's California Environmental Quality Act (CEQA) Guidelines.

Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with Goal No. 2. Ensure the Public Health and Safety and Provide Essential Infrastructure.

Executive Summary and Discussion:

County Service Area No. 41 was established to finance road maintenance on certain private roads in the Cebada Canyon area. In FY 2003-04, \$41,000 was expended in this area for road maintenance. The average assessment of \$465.00 should be maintained for FY 2004-05, pursuant to the community's input. The proposed assessment will generate approximately \$23,000.00 in revenues.

Pursuant to the County's CEQA guidelines, the Department of Public Works has determined this project

to be exempt from further environmental review. Approval of this Notice of Exemption shall indicate the Board of Supervisors' approval of this project and will commence the appeal period, pursuant to CEQA guidelines.

Mandates and Service Levels:

No change in programs or service level.

Fiscal and Facilities Impacts:

This Service Area is self-financed and there is no General Fund impact. Revenues of \$23,000.00 were budgeted in Department 054 (Public Works), Fund 2242 (CSA 41), Maintenance cost center of the Transportation Division shown on page D- 318 of the budget for fiscal year 2004-05.
