**SUBJECT:** Establishment of the 2007-08 Library Tax Rate for County Service Area #3 (Goleta)

**Recommended Action(s):**

That the Board of Supervisors set a hearing for July 17, 2007 to consider adopting a resolution that increases the 2007-08 library special tax rate in County Service Area #3 (Goleta), by 4.3% CPI adjustment for 2006.

**Summary:**

The assessment for FY 2007-08 is proposed to increase by 4.3%, which reflects the CPI adjustment for 2006. The chart below shows proposed changes in tax rates by parcel category:

A written report detailing the 2007-08 tax per parcel for CSA #3 will be filed with the Clerk of the Board. A second copy will be available for public viewing at the Goleta Library.

Attachment (1) is a summary of the library tax proposed for parcels located in the unincorporated area of County Service Area 3, outside the boundaries of the City of Goleta.

Attachment (2) is the proposed Board of Supervisors' resolution that sets the tax for County Service Area #3 for the 2007-08 fiscal year.

**Background:**

In June 1990, more than 2/3 of the voters in CSA #3 (Goleta) approved a special tax to fund enhanced services at the Goleta Library. In accordance with the terms of ballot Measure L that authorized the special tax, your Board must hold a public hearing to annually fix the amount of tax to be collected. The tax can be adjusted each year for changes in the cost of living. Changes in the cost of living are based upon the percentage change in the Consumer Price Index (CPI) for the Los Angeles/Anaheim/Riverside area using the calendar year immediately preceding the applicable tax year as the base.

Narrative:

County Service Area #3 special tax proceeds for the library are proposed to increase from \$150,111 for 2006-07 to approximately \$156,566 for 2007-08, within the unincorporated area. The increase is the result of the 4.3% CPI adjustment and additional new taxable units within CSA #3. The \$156,566 will help fund operating costs for the Goleta Library for Fiscal Year 2007-08.
