WHEREAS, the Orcutt Fire Protection District and the County of Santa Barbara have entered into the attached Memorandum of Understanding (Attachment A), which authorizes the Santa Barbara County Fire Department to provide fire/life safety protection and code enforcement in the Orcutt Fire Protection District; and

WHEREAS, the Orcutt Fire Protection District and the County of Santa Barbara desire to initiate a proceeding for the adjustment of boundaries to annex territory within the Orcutt Fire Protection District to the Santa Barbara County Fire Protection District;

NOW, THEREFORE, the Board of Directors of the Orcutt Fire Protection District and Board of Supervisors of the County of Santa Barbara do hereby jointly resolve and order as follows:

- 1. This proposal is made, and it is requested that proceedings be taken, pursuant to the Cortese/Knox/Hertzberg Local Government Reorganization Act of 2000, commencing with section 56000 of the California Government Code.
  - 2. This proposal is a reorganization that consists of
    - A. Annexation to the Santa Barbara County Fire Protection District and

- B. Dissolution of the Orcutt Fire Protection District.
- 3. The territory to be annexed consists to all territory within the Orcutt Fire Protection District as the boundaries of the District exist on April 21, 2008.
- 4. It is desired that the proposal be subject to the terms and conditions set forth in the attached Memorandum of Understanding (Attachment A).
- 5. The reasons for the proposal are elaborated upon in the attached Memorandum of Understanding (Attachment A).
- 6. The proposal is consistent with the Sphere of Influence of the annexing District.
