The recommendations are primarily aligned with Goal No. 1, An Efficient Government Able to Anticipate and Respond Effectively to the Needs of the Community.

Executive Summary and Discussion:

This project consisted of seismic retrofitting Bridge 51C-161, by installing four, 48" diameter cast-in-place piles and two pile caps. The existing columns were fitted with steel casings and their footings received an additional top mat of reinforced concrete. All the proposed work was performed within the foot print of the existing structure. Your Board approved this project as part of the 2002/2003 Capital Improvement Plan. This project began on March 29, 2004 and the Director of Public Works accepted this project as complete on September 8, 2004. The project was completed on time and on budget.

Mandates and Service Levels:

No change in programs or service levels.

Fiscal and Facilities Impacts:

The Highway Bridge Replacement and Rehabilitation (HBRR) program provided 80% of the funding for this project, and the remaining 20% HBRR matching funds were provided by Measure 'D' monies. Measure 'D' funding for the project was budgeted in Fund 0015, Department 054, Account 7511, and Program 2900.
