**Summary Text:** The project consists of the rehabilitation of the following (3) access stairway locations to the beach areas:

- Southerly terminus of Camino Pescadero
- Southerly terminus of Camino Del Sur
- Escondido Pass

in the Isla Vista area, Third Supervisorial District, County Project No. 862252.

The Santa Barbara County Public Works Department, Traffic Section proposes to rehabilitate the above mentioned stairways for the purpose of overall public safety and required beach access.

The "Notice to Contractors" will be published prior to the date set for the opening of the bids. Sealed proposals to construct this project will be received at the Public Works Conference Room, Santa Barbara County, Department of Public Works, County Engineering Building, 123 East Anapamu Street, Santa Barbara, California and at the North County Public Works office, 620 West Foster Road, Santa Maria, California, at a date to be determined, and will be opened publicly and read aloud.

<u>Background:</u> Plans have been developed to rehabilitate the three coastal access stairways in the Isla Vista area. Due to the years of damage caused by the harsh marine environment, it is necessary to repair or replace portions of these stairways so they remain safe and beach access is maintained.
