**SUBJECT:** Speed Zone: Patterson Avenue; Second Supervisorial District.

#### RECOMMENDATIONS

C.A. Recommendation:

That the Board of Supervisors:

- A. Set a public hearing for **September 21, 2004** to consider introduction of an ordinance amending Chapter 23, Sections 23-15.5, of the Code of Santa Barbara County, pertaining to speed limits on a certain County Road described herein.
- B. Conduct a second hearing on **September 28, 2004** and adopt the attached ordinance, amending Chapter 23, Sections 23-15.5, of the Code of Santa Barbara County, pertaining to speed limits on the subject road described herein.

### ALIGNMENT WITH BOARD STRATEGIC PLAN

The recommendations are primarily aligned with the following Goals: #2) Ensure the Public Health and Safety and Provide Essential Infrastructure, and #5) Maintain and Enhance the Quality of Life for all Residents.

### **EXECUTIVE SUMMARY & DISCUSSION**

The California Vehicle Code requires that speed limits on roadways be established based on the findings of an Engineering and Traffic Survey. California law prohibits the use of radar speed enforcement along such roadways where the speed limit has not been set in accordance with the findings of this type of study within the last seven to ten years.

In accordance with the California Vehicle Code, the Public Works Department has prepared Traffic and Engineering Survey for Patterson Avenue in the Goleta area. This survey was performed based on a request by the Second Supervisorial District's office.

The Traffic Section will review the recommendations from the Traffic Engineering Committee on September 8, 2004 and will include those recommendations at the first hearing. The following is the Traffic Section's proposed speed limit on Patterson Avenue:

### PATTERSON AVENUE

Boundary	Existing Enforceable Speed Limit	Critical Speed	Proposed Enforceable Speed Limit
Shoreline Drive to City Limits of Goleta	55 MPH	46 MPH	45 MPH

All recommended changes would be enforceable by radar, in compliance with State law.

### MANDATES & SERVICE LEVELS

No mandates or service levels are affected by these actions.

### **FACILITIES AND FISCAL IMPACT**

Approximately \$500.00 will be required to post signs and paint legends. Funding is available in the County Public Works Department Budget #054, Fund 0015, Program 2200, and Account #7121.
