Re: Termination of Agreement for Services of Independent Contractor with Merakey Allos for Fiscal Years 2021–24 (Board Contract No. 21-022) and Any Amendments Thereto ("Agreement"), Effective May 16, 2024

Dear Tinnesia Snyder,

In accordance with Section 19 (Termination) of the above-referenced Agreement, the County of Santa Barbara Department of Behavioral Wellness issues this notice to terminate the Agreement for convenience. Termination is necessary because of Merakey Allos' staffing-related challenges including the recent loss of key clinical staff.

On May 7, 2024, Behavioral Wellness will seek to terminate the Agreement with a termination effective date of **May 16, 2024**. To cover Merakey Allos' operating costs including those required to ensure the orderly transition of clients to a new service provider and eliminate the interruption of services to clients, Behavioral Wellness will also seek to increase the original agreement amount by \$30,700 for a new, total maximum contract amount of \$1,932,700. <u>Any amendment to or termination of the Agreement is contingent upon approval by the County of Santa Barbara Board of Supervisors.</u>

Pursuant to Section 19.A.1 (For Convenience), please wind down and cease services under the Agreement. Additional instructions concerning the wind down process will follow this notice.

As indicated in Exhibit B-MHS, Section VI, Part D (Withholding of Payment for Non-submission of Service Data and Other information) of the Agreement, final payment shall be withheld until Behavioral Wellness is in receipt of complete and correct data, and this data has been reviewed and approved by the Behavioral Wellness Director or designee. The Director or designee will review this data within 60 calendar days of receipt. In addition, in accordance with Exhibit B-MHS, Section VIII (Cost Report) of the Agreement, we require your agency to submit a Cost Report following the end of the 2023–24 fiscal year.
