#### **Recommended Actions:**

That the Board of Supervisors consider and authorize the Chair to sign, on behalf of the Board, a letter to the Judicial Council of California supporting adoption of recommendations allowing the Santa Barbara Superior Court's new criminal court building project to move forward.

#### **Summary Text:**

A new criminal court building project in Santa Barbara received a unanimous recommendation of support from the Court Facilities Working Group. The Judicial Council of California is set to consider for adoption these recommendations from the Working Group for moving ahead a variety of courthouse projects across the state, including Santa Barbara. Since funding is less than required for all court projects and the current dangerous practice of walking prisoners back and forth across the street between existing court facilities is not sustainable, the Board's letter of support would be an important contribution to the decision making process.

#### **Background:**

The new criminal court building will be located within the downtown civic core of Santa Barbara. It will provide a much needed new criminal courthouse and will also enhance the economy of our County.

The construction of a new criminal courts building in conjunction with the renovation and integration of the existing Figueroa Courthouse will improve security. It remedies a dangerous and long-standing situation where inmates are walking across our public streets every day. There is strong competition for the limited SB 1407 money available for construction projects. If authorized, the attached letter of

support would be sent to the Judicial Council of California promoting the adoption the unanimous recommendation of the Court Facilities Working Group to allow the Santa Barbara Superior Court's project to move forward.
