Additionally, Manager Stanley held positions as a Deputy Probation Officer III and Supervising Probation Officer; and

**WHEREAS**, during her tenure with the Santa Barbara County Probation Department, Manager Stanley worked in all four Divisions of the Department and interacted with numerous officers, adults and youth, many of which have benefitted from her passion for effecting change. Additionally, she mentored and trained many officers, positively impacting their professional development; and

**WHEREAS**, Manager Stanley received several accolades during her career, receiving: the Probation Peace Officer Association Community Enrichment Award in 2005; Santa Barbara County Probation Department Chief's Award in 2015; was named a Paul Harris Fellow by Rotary International in 2016; and received a Certificate of Recognition from State Senator Hannah-Beth Jackson for Outstanding Contributions to the Santa Barbara Community in 2018; and

**WHEREAS**, Manager Stanley is looking forward to spending time with her husband Britt, daughter Johanna, son Cameron, and continuing to follow the New York Giants and Los Angeles Angels. She will be relocating to Tennessee and is planning to make many new memories with her family and friends.
