Brief CRMF Overview

- Three oil and gas facilities pay into CRMF annually:
 - Point Arguello, Point Pedernales and Santa Ynez Unit
- CRMF Guidelines stipulate:
 - 50% of CRMF fees go towards coastal acquisition projects
 - Other 50% towards general allocation and coastal acquisition projects
- Staff solicits, evaluates, and recommends proposals for CRMF awards
- Board of Supervisors awards grants


