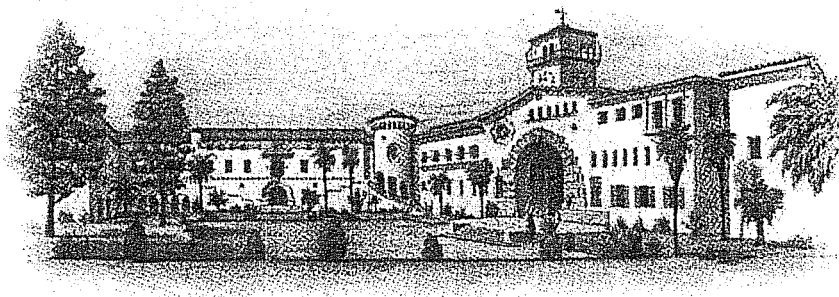

I'm a registered civil engineer, State of California. I retired in Jan 2009 after 37-1/2 years of federal service as an engineer, manager and supervisor with responsibilities for facility renovation, maintenance and repair on Air Force bases in California, Japan and Germany. Historic landmarks define the character of a locale, without which education and tourism suffer. The HLAC is the key first step towards landmark identification and preservation.
