SUBJECT: New County Jail Planning Study

Recommendation:

That the Board of Supervisors set a hearing for Tuesday, December 13, 2005, to receive a jail planning study including options for constructing and operating a new County Jail as well as alternatives for relieving current overcrowding conditions at the existing jail.

Alignment with Board Strategic Plan:

The recommendation is primarily aligned with Goal No. 2. A Safe and Healthy Community in Which to Live, Work, and Visit.

Executive Summary and Discussion:

On April 12, 2005, the Board received an informational presentation on the status of jail overcrowding and jail property acquisition in the North County from the Sheriff. At this meeting, the Board directed the Sheriff and the County Executive Officer to proceed with planning for a new jail at the Laguna County Sanitation District site as well as alternatives for relieving short-term jail overcrowding issues, and return to the Board with recommendations as appropriate. The County Executive Officer has compiled a team consisting of CEO, Sheriff, County Counsel, Planning and Development, Public Works, Auditor-Controller, General Services and Treasurer-Tax Collector staff to develop a jail planning study.
