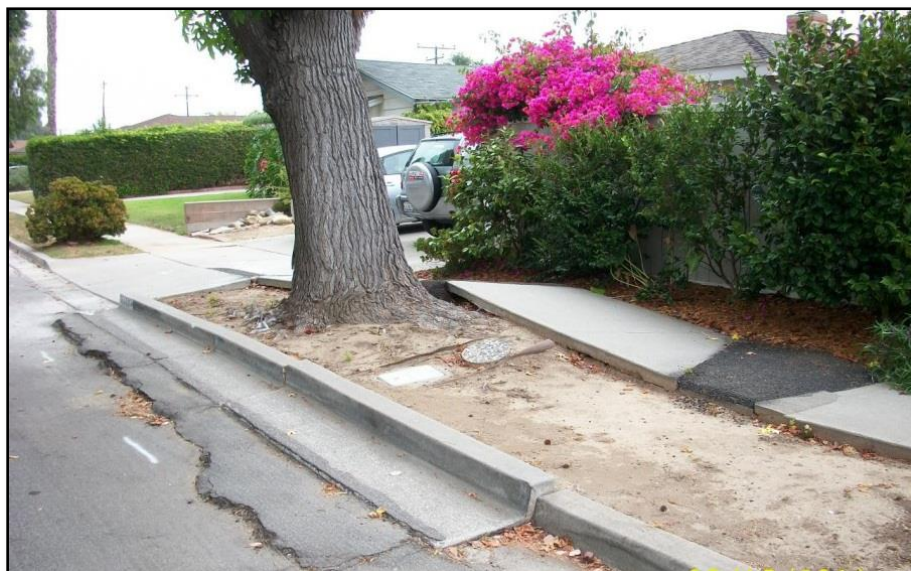
Summary Text:

This project was part of the Public Works Department's annual Preventive Maintenance Program. This project replaced approximately 720 linear feet of sidewalk, 940 linear feet of curb and gutter and the installed 25 new ADA-compliant curb ramps. This Second District Project is similar to those ongoing or completed projects in the First, Third, and Fourth Districts as part of the Road Maintenance Annual Plan (RdMAP).

The Director of Public Works accepted this project as complete on August 29, 2012. The project was completed on time and on budget.

Background:

On May 8, 2012, your Board found the administrative activities for this project, including the Statement of Final Quantities, to be exempt from CEQA, as such activities do not constitute a "Project" within the meaning of CEQA, pursuant to 14 CCR 15378(b)(2), and approved and authorized staff to file a Notice of Exemption.
