SUBJECT: No Parking Zones on Sabado Tarde Road in the Third Supervisorial District.

# **RECOMMENDATIONS:**

C.A. Recommendation:

That the Board of Supervisors adopt a resolution establishing "No Parking" zones on Sabado Tarde Road to support bus operations in the Isla Vista area.

#### ALIGNMENT WITH BOARD STRATEGIC PLAN:

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure.

# **EXECUTIVE SUMMARY & DISCUSSION:**

Currently, the Santa Barbara Metropolitan Transit District (MTD) provides transit service to the residents of Isla Vista, via six bus routes. These routes travel through the northern portion of Isla Vista from the University of California at Santa Barbara (UCSB) but are limited to travel through the West Gate of campus. Due to the lack of service in the southern portion of Isla Vista, MTD partnered with the County of Santa Barbara and UCSB to install a transit gate at Ocean Road and Sabado Tarde Road. This gate will enable transit buses to directly access the southern portion of Isla Vista. When installation of the gate is completed in mid-September 2003, the MTD will re-route one of the six bus routes that serve Isla Vista to provide easier access to transit for individuals residing in the southern portion of Isla Vista. On weekdays, this service will run with a minimum frequency of 30 minutes and will provide a direct connection from the southern portion of Isla Vista to UCSB as well as providing a link to the Camino Real Marketplace.

- On the south side of Sabado Tarde Road between the centerline of Camino Del Sur and a point 82 feet east of the centerline of Camino Del Sur.
- On the south side of Sabado Tarde Road between the centerline of Camino Pescadero and a point 73 feet east of the centerline of Camino Pescadero.

- On the north side of Sabado Tarde Road between the centerline of El Embarcadero and a point 92 feet west of the centerline of El Embarcadero.
- On the south side of Sabado Tarde Road from a point 200 feet east of the centerline of El Embarcadero to a point 270 feet east of the centerline of El Embarcadero.
