The owner was well aware ofthe park conditions, but chose to ignore the situation, and now is trying toput the liability on the residents. Ifyou do your research on the computer, you will find that our owner iswell-known as a mobile home "slum lord" in California, and this is atypical move for him.

Manufactured-homeowners in Santa Barbara County need a strong Rent Control Ordinance to ensurethat rent increases are fair and park owners don't take advantage of theresidents to line their own pockets. Many of us are elderly, disabled, orlow-income working families, and live on fixed incomes. Manufacturedhousing communities are among the only affordable housing options available inour county. However, we are vulnerable because although we own our homes, we rent the land they sit on. We must depend upon our ordinances, and those who administer them, to ensure fairness for both themanufactured-home owners and the park owner.

Please uphold our Rent Control Ordinance, and hold the park owner accountablefor abiding by it.
