Authorize the Chair of the Board of Supervisors to execute <u>First Amendment to the Lease Agreements</u> between the County of Santa Barbara and Mr. and Mrs. Hart for the lease of two unimproved parcels of land they own which are adjacent to the Tajiguas Landfill.

Summary Text:

Mr. and Mrs. Hart own two contiguous and unimproved parcels of land adjacent to the Tajiguas Land fill. The Hart parcels are known as Assessor's Parcel numbers 081-150-033 and 081-150-034. The total rent paid for both parcels is \$1,025.00 per month gross. The amended lease term is five years, ending September 30, 2012. At that time the County through the Director of Public Works has an option to extend the lease term for an additional five years, terminating September 30, 2017.

Background:

Resource Recovery and Waste Management Division has been leasing the subject parcels since 2001, and enter the parcels for weed abatement, litter control and water testing, all of which improve the Division's ability to protect the environment and comply with State regulations. The County may terminate these leases without cause and at any time upon sixty (60) day written notice.
