

**TENTATIVE AGREEMENT
SERVICE EMPLOYEES INTERNATIONAL UNION, LOCAL 620 AND
SANTA BARBARA COUNTY REGARDING
JANUARY 2023 SALARY EQUITY ADJUSTMENTS**

The parties have met and conferred in good faith pursuant to Section 17. E of the current Memorandum of Understanding between SEIU Local 620 and Santa Barbara County and pursuant to Section 3500 of the California Government Code.

The parties tentatively agree that employees in the following job classifications represented by SEIU Local 620 shall receive the equity adjustments indicated:
