#### **Recommended Actions:**

Approve Amendment #3 to the Professional Services contract with Lenvik & Minor Architects for the Isla Vista Fool Patrol Project which extends the Contract time from July 30, 2008 to January 30, 2009 and increases the not-to-exceed amount by seventy five thousand dollars and no cents (\$75,000.00) to a total of \$246, 079.02.

#### **Summary Text:**

On August 2, 2005 the Board approved an executed a Professional Services Contract with Lenvik & Minor Architects for architectural, engineering and construction administration services associated with the new Isla Vista Foot Patrol building. Due to the extraordinary time involved in obtaining the required governmental clearances (i.e. CEQA, land lease agreement, California Coastal Commission and Campus design review) along with delays during the construction (i.e. weather delays, design changes required by code, material delays, and water main improvements required by Goleta Water District) the expected project time exceeded the initial completion schedule. This amendment #3 extends the contract time from July 30, 2008 to January 30, 2009 and increases the contract amount by \$75,000 to a total of \$246.079.02.

<u>Background</u>: On July 13, 2004 the Board authorized the Sheriff's Department to proceed with the planning of the new Isla Vista Foot Patrol offices and to negotiate with a qualified architectural firm to provide the necessary construction documents and construction administration for the project.

On August 2, 2005 the Board executed a Professional Services Contract with Lenvik & Minor Architects for architectural, engineering and construction administration services relating to the design and construction of the Isla Vista Foot Patrol Offices.

On June 19, 2006 the Board approved Amendment #1 to the Professional Services Agreement with Lenvik & Minor Architects increasing the Contract amount from \$164,500 to \$171,079.12.

On November 6, 2007 the Board approved Amendment #2 to the Professional Services Agreement with Lenvik & Minor Architects extending the contract end date from December 30, 2006 to July 30, 2008.
