## **Recommended Actions:**

- 1. Approve Amendment #1 to the Professional Services contract with Kruger Bensen Ziemer Architects, Inc. (a local vendor) for the Technical Services Project which extends the Contract time from August 30, 2007 to December 31, 2011.
- 2 Approve Budget Revision Request #2007556 for \$200,000 for architectural services for the Technical Services Building in FY2008-09.

## **Summary Text:**

On November 22, 2005 the Board approved an executed a Professional Services Contract with Kruger Bensen Ziemer Architects, Inc. for architectural, engineering and construction administration services associated with the new Technical Services building on the Sheriff Admin campus. Due to the extraordinary time involved in the design of the structure the expected project time exceeded the initial completion schedule. This amendment #1 extends the contract time from August 30, 2007 to December 31, 2011.

<u>Background:</u> On July 13, 2004 the Board authorized the Sheriff's Department to proceed with the planning of the new Technical Services building and to negotiate with a qualified architectural firm to provide the necessary construction documents and construction administration for the project.

On November 22, 2005 the Board executed a Professional Services Contract with Kruger Bensen Ziemer Architects, Inc. for architectural, engineering and construction administration services relating to the design and construction of the Technical Services building. The contract is for a value not to exceed

\$472,500 and expired August 30, 2007. To date, the project has paid \$218,787 to the vendor for services rendered. Additional work has been performed and the project is at a critical stage. This amendment will extend the contract to December 31, 2011 to allow for design work to be completed and project management to be provided once construction funds are secured.
