To Clerk of the Board - Katherine Douglas,

I am writing to bring to your attention the situation at Del Cielo Mobile Estates concerning the moratorium established by the Santa Barbara Board of Supervisors through Ordinance No. 5225 on December 20, 2024. This ordinance prohibits the conversion of senior mobile home parks and age-restricted mobile home parks into all-age mobile home parks.

Since the moratorium was enacted, the owners of Harmony Communities have been selling homes in Del Cielo Mobile Estates to families with children, while not allowing any residents over the age of 55+. This practice has been ongoing since January 1, 2025, and continues to the present day. Furthermore, they have instructed all realtors selling in the park to list homes as "all-age park." I believe Harmony is attempting to exceed the 20% HOPA (Housing for Older Persons Act) regulation to circumvent the overlay. Does this not violate the moratorium that the Supervisors put in place?

The sale of homes to these new families has created an unsafe environment for our senior residents. This situation has caused significant unrest in our community, particularly since families with young children and teenagers have moved in. The Residents are experiencing several thefts in our clubhouse. Del Cielo has seen the sheriff and probation officers many times in our park over the last several months due to arrests made for probation violations and disturbing the peace.

Some residents have reported seeing people come and go from a particular house at all hours of the night. We are vulnerable and wide open to any danger or event that may transpire. Our community has faced numerous challenges since Harmony took over. Earlier this year, they removed our RV parking and the Senior Garden, which was permitted by the original owners, without providing any explanation—just a notice.

I have attached a list of homes owned by Harmony and another containing some of the realtor's advertisements, which demonstrate their aggressive attempts to sell as many homes as possible to families. The Realtors are told by Harmony to list the property as an "All Age Park" on the MLS, your attention to our issues with Harmony is urgently needed. Please let us know what can be done to address these concerns.
