AB 1666 creates a statewide licensing program, establishes a mechanism to prevent the sale of cigarettes produced by manufacturers who do not comply with the Master Settlement Agreement of 1998, and establishes penalties for non-compliance. However, opponents of AB 1666 have labeled it "The Tobacco Industry Protection Act of 2002", and state that it has no public health value, allows the Board of Equalization to raid Prop 99 and Prop 10 funds to administer anti-smuggling programs, and may preempt local tobacco control ordinances;
- d) Consider, without a recommended action by the Legislative Program Committee, SB 1785 (Vasconcellos, D-Santa Clara) Hypodermic Needles and Syringes. SB 1785 would authorize a licensed pharmacist to sell hypodermic needles or syringes, without a prescription, under specified conditions. SB 1785 requires oversight of clean needle exchange programs by the local health officer, but may eliminate the need for the Board's local declaration of an emergency every two weeks;
- e) Receive a copy of a letter to Thomas Scully, Centers for Medicare and Medicaid Services, signed by the Board Chair, which encourages the Federal Government to support the extension of California's Selective Provider Contracting Program (SPCP) Federal Waiver and requests that no precipitous action, which could result in the of elimination of the waiver, be taken. This is consistent with Board Policy;
- f) Adopt the attached Resolution to: 1) Support the Water Security, Clean Drinking Water, Coastal and Beach Protection Act of 2002, a statewide initiative, qualified for the November 5, 2002 ballot, which, if passed, will provide \$3.44 billion for water projects in California, and 2) Support the Public Works Department participation in the Northern and Coastal California Water Bond Initiative Coalition which seeks to allocate funding from the Water Security, Clean Drinking Water, Coastal and Beach Protection Act of 2002, for local projects, and 3) Consider appointing a member of the Board of Supervisors to serve as a representative of the County in the Northern and Coastal California Water Bond Initiative Coalition (Attachment F contains additional information in Board Letter format);
