RESOLUTION HONORING DR. TERESA MARTINEZ-BAKER THE LOMPOC VALLEY WOMAN OF THE YEAR FOR 2015

WHEREAS, Dr. Teresa Martinez-Baker is a Lompoc native who graduated from Lompoc High School and returned to her hometown after college to open her own Chiropractic office in 2006 and;

WHEREAS, Dr. Martinez-Baker has been an active member of the Lompoc Valley Chamber of Commerce, the Hispanic Business Committee and the Lompoc Business Women's Network and;

WHEREAS, Dr. Martinez Baker has volunteered her time with the Lompoc High School Alumni Association, the Every 15 Minutes Program, Relay for Life, various youth sports programs and the River Bend Bike Park and;

WHEREAS, Dr. Martinez-Baker and her husband founded the Dr. T's Relay for Life Team in 2008, which has since raised approximately \$80,000 for cancer research, and their flagship fundraiser "Dr. T's Strike Out Cancer Softball Showdown," which was the first co-ed slow pitch softball tournament played on Lompoc ball fields, has become the tournament the local community looks forward to every year and;

WHEREAS, Dr. Martinez-Baker sponsors numerous youth sports teams, including making herself available to perform free physical exams for student athletes and has volunteered to be a physician on the sideline during Lompoc home football games and;

WHEREAS, Dr. Martinez-Baker has done pro-bono adjustments to help out citizens of the Lompoc Valley, and as she truly cares about her patients' well-being, will come in on her days off if required and continually goes out of her way to assist anyone that needs her help and;

WHEREAS, Dr. Martinez-Baker and her husband have been instrumental in the planning, building and operation of the River Bend Bike Park and have volunteered countless hours with their three children alongside them and;

WHEREAS, Dr. Martinez-Baker demonstrates her compassionate character on a daily basis and instills in her children a good work ethic, a sense of integrity & respect and takes utmost pride in her community;
