NOW THEREFORE, IT IS HEREBY RESOLVED AND ORDERED that the following locations in Santa Barbara County and under the jurisdiction of the Board of Supervisors of said County are hereby designated as No Parking:

No Parking Zone

- On the east side of La Cumbre Road between the centerline of Pemm Place and a point 100 feet north of the centerline of Pemm Place.
- On both sides of Iaiqua Lane between the centerline of Foothill Road and a point 106 feet north of the centerline of Foothill Road
- On the north side of Foothill Road between the centerline of Iaiqua Lane to a point 112 feet east of the centerline of Iaiqua Lane.
- On both sides of Calle Real between the centerline of El Sueno Road and the centerline of San Antonio Road.
- On both sides of Orcutt Road between the centerline of Winter Road to State Route 135.
- On both sides of Orcutt Road between the centerline of Lakeview Road to a point 140 feet north of the centerline of Lakeview Road.

IT IS FURTHER RESOLVED that the Santa Barbara County Director of Public Works or designee is hereby authorized and directed to designate said locations with appropriate markings and/or signs as time and resources permit.
