SUBJECT: Construction of Mahoney Road Storm Damage Repairs 1.22 Kilometers (0.76 miles) South of Betteravia Road Near the City of Santa Maria, California, in the Fourth Supervisorial District. Santa Barbara County Project No. 01STRM

Recommendation(s):

That the Board of Supervisors:

Accept Notice of Completion for work performed by the Contractor, Elevation General Engineering (a local vendor), 2336 Skyway Drive, Suite 4, Santa Maria, CA 93455, and authorize Clerk to record.

Alignment with Board Strategic Plan:

The recommendations are primarily aligned with Goal No. 1, An Efficient Government Able to Anticipate and Respond Effectively to the Needs of the Community.

Executive Summary and Discussion:

This project was located on Mahoney Road, 0.76 miles south of Betteravia Road west of the City of Santa Maria. During the 2001 winter storms, heavy rains and high run-off saturated the roadway embankment causing the slope to fail and a portion of the drainage pipe to fail. The work consisted of re-grading the roadway slope, installation of new storm drain systems and rock slope protection to repair the storm damaged roadway.

Your Board approved this project in the Fiscal Year 2003/2004 Capital Improvement Plan. The final plans were approved and the project was awarded on June 15, 2004. The Director of Public Works accepted this project as complete on September 28, 2004. The project was completed on time and on budget.
