<b><u>Clerk of the Board Agenda Deadline:</u></b> Last day to file with the Clerk of the Board of Supervisors the original and seven (7) copies of the district board's resolution requesting consolidation with the election.	6/26/14 E-131
<b><u>Board of Supervisors Meeting:</u></b> Last meeting of the Board of Supervisors to approve the request for consolidation with the election. The following items listed on this calendar of events are based on the Board of Supervisor's approval of the consolidation at the 7/8/14 meeting.	7/8/14* E-119
<b><u>Board of Supervisors directs Auditor to prepare Fiscal Impact Statement:</u></b> Last meeting scheduled prior to the 88 <sup>th</sup> day before the election, the deadline for the Board of Supervisors to direct the Auditor to prepare a Fiscal Impact Statement. Therefore, if the Board of Supervisors chooses to direct the Auditor to prepare a Fiscal Impact Statement on a proposed county initiative the deadline to do so is July 8, 2014.	7/8/14* E-119
<b><u>Publication-Notice of Election &amp; Notice to Submit Arguments:</u></b> Publication by County Clerk, Recorder and Assessor of date for submission of direct arguments for and against the measure.	7/13/14** E-114
<b><u>Period for Submitting Direct Arguments:</u></b> Written direct arguments for and against the measure are to be submitted within this time frame. Ten (10) Day Public Exam period to follow the deadline to submit direct arguments.	7/14/14 – 7/23/14 E-113 to E-104
<b><u>Deadline for Impartial Analysis:</u></b> Deadline for submittal of Impartial Analysis prepared by legal counsel to the Elections Official. Ten (10) Day Public Exam period to follow the deadline to submit Impartial Analysis.	7/23/14 E-104
<b><u>Period for Submitting Rebuttal Arguments:</u></b> Written rebuttal arguments by the authors of the direct arguments are to be submitted within this time frame. Ten (10) Day Public Exam period to follow the deadline to submit rebuttal arguments.	7/24/14 – 8/4/14*** E-103 to E-94
<b><u>Tax Rate Statement:</u></b> Deadline to file a tax rate statement for a bond measure to the Elections Official (if applicable).	8/8/14 E-88
<b><u>Deadline for Fiscal Impact Statement:</u></b> Deadline for submittal of the Fiscal Impact Statement prepared by the Auditor to the Elections Official. Ten (10) Day Public Exam period to follow the deadline to submit the Fiscal Impact Statement.	8/4/14 E-92
<b><u>Election Official's Deadline for Submission of Local Measure Information to Printer:</u></b> Completion of submission of ballot/sample ballot material to printer by County Elections Official.	8/22/14**** E-74

**IMPORTANT NOTE FOR CITIES:**

Cities are responsible for the publication of the "Notice of Election" for their measures and the publication of the "Notice to Submit Arguments"; the receiving and processing of direct arguments/rebuttal arguments; the preparation of the Impartial Analyses and the 10-Day Public Examination Period. Due to this fact the deadline for a city to request consolidation with the election is the 88<sup>th</sup> day prior to Election Day. The 88<sup>th</sup> day falls on August 8, 2014.

Due to the Board of Supervisors adopted schedule please be advised of the following deadlines:

Last scheduled Board of Supervisors meeting prior to the 88<sup>th</sup> day: July 8, 2014;

Deadline for a city to submit a resolution requesting consolidation with the Clerk of the Board of Supervisors for the July 8, 2014 meeting: June 26, 2014.

The city must submit a calendar of events and deadlines to the Elections Office by July 8, 2014.
