RE: California Tiger Salamander Conservation Easement Government Code Consistency; 10GOV-00000-00011

Hearing on the request of Ronn Carlentine, Manager of the Office of Real Estate Services, General Services Department, to consider Case No. 10GOV-00000-00011 [application filed on August 11, 2010], for a determination that the proposed grant and conveyance of a Conservation Easement for California Tiger Salamander (CTS) for the purpose of supporting the environmental value of wildlife habitat, open space and productive farmland and agricultural activities is consistent with the Comprehensive Plan. The site is identified as AP No. 099-060-021, located approximately 1¾ miles southeast of the intersection of Highway 246 and Santa Rita Road, Lompoc area, Third Supervisorial District.

Dear Mr. Carlentine:

At the Planning Commission hearing of September 8, 2010, Commissioner Brooks moved, seconded by Commissioner Cooney and carried by a vote of to 4-0 (Blough absent):

- 1. Determine that the proposed grant and conveyance of a Conservation Easement for California Tiger Salamander (CTS) for the purpose of supporting the environmental value of wildlife habitat, open space and productive farmland and agricultural activities is consistent with the Comprehensive Plan; and
- 2. Transmit the consistency report required by Government Code Section 65402 to Florence Trotter-Cadena (Planning & Development) and the Board of Supervisors. The memo dated August 11, 2010, and the letter reflecting the County Planning Commission's action shall constitute the required report.

The Planning Commission action relative to Government Code §65402 is advisory in nature; therefore the appeal procedure is not applicable. Your Commission's determination will be forwarded to the General Services Department and the Board of Supervisors.

Hearing on the request of Ronn Carlentine, Manager of the Office of Real Estate RE: Services, General Services Department, to consider case no. 10GOV-00000-00011, application filed on August 11, 2010, for a determination that the proposed grant and conveyance of a Conservation Easement for California Tiger Salamander (CTS) for the purpose of supporting the environmental value of wildlife habitat, open space and productive farmland and agricultural activities is consistent with the Comprehensive Plan. The site is identified as Assessor Parcel Number 099-060-021, located approximately 134 miles southeast of the intersection of Highway 246 and Santa Rita Road, Lompoc area, Third Supervisorial District.

Project Description: The proposed project consists of the acquisition of a Conservation Easement for California Tiger Salamander (CTS) and expected conveyance of this easement to the Land Trust of Santa Barbara County. The County is funding the acquisition of this conservation easement, pursuant to a Conditional Settlement Agreement between the County and the United States Fish and Wildlife Service (FWS). The proposed conservation easement of approximately 15.4 acres would be located in the northwest corner of a 120 acre parcel. The purpose of the easement is to support the environmental value of wildlife habitat, open space and productive farmland and agricultural activities that are consistent with the preservation and protection of the migratory activities of the federally protected California Tiger Salamander.

Consistency with Applicable Comprehensive Plan Policies:

The request is for a determination that the project is consistent with the Comprehensive

Agricultural Element, Goal I. Santa Barbara County shall assure and enhance the continuation of agriculture as a major viable production industry in Santa Barbara County. Agriculture shall be encouraged.

Consistent: The current agricultural activities on the subject parcel consist of cattle grazing and dry crops (e.g., oat hay, beans). Both would continue to occur on the parcel, but in different areas. Conversion of habitats within the CTS easement would be precluded; however, the easement is primarily located on hillsides, which are not readily

accessible for dry farming. According to USFWS (Federal Register, Vol. 65, No. 184, page 57261; September 21, 2000), grazing generally is compatible with the continued use of rangelands by the California tiger salamander in Santa Barbara County, as long as intensive burrowing rodent control programs are not implemented on such areas and grazing is not excessive. The property owner has recently applied to enroll in the agricultural preserve program. The proposed project would be consistent with this policy.

Policy #7: Degradation of the water quality of groundwater basins, nearby streams, or wetlands shall not result from development of the site. Pollutants, such as chemicals, fuels, lubricants, raw sewage, and other harmful waste, shall not be

discharged into or alongside coastal streams or wetlands either during or after construction.

The proposed conservation easement would protect one known (LOAL-33) and one potential (LOAL-49) CTS breeding pond, and a surrounding grassland and coastal sage area for interpond migration. The easement would not degrade the groundwater basins, streams or wetlands, as no development could result as part of the easement. No pollutants will be discharged as the easement is for the purpose of supporting the environmental value of wildlife habitat, and open space, productive farmland, and agricultural activities. Therefore, the proposed project would be consistent with this policy.

Recommendation: That the Planning Commission:

- 1. Determine that the proposed grant and conveyance of a Conservation Easement for California Tiger Salamander (CTS) for the purpose of supporting the environmental value of wildlife habitat, open space and productive farmland and agricultural activities is consistent with the Comprehensive Plan; and
- 2. Transmit the consistency report required by Government Code Section 65402 to Florence Trotter-Cadena (Planning & Development) and the Board of Supervisors. The memo dated August 11, 2010, and the letter reflecting the County Planning Commission's action shall constitute the required report.



LOCATION: The owner's property is known as 3200 Gypsy Canon Road, in the unincorporated area of Lompoc, CA. The property consists of approximately 160 acres. The easement area consist of four areas A, B, C, and D, where areas A, B, C shall be preserved for agricultural activities that are consistent with the preservation and protection of the migratory activities of the CTS in the easement area, and where area D shall be preserved for the enhancement and preservation of a potential breeding Pond 49 for the CTS, all legally described and shown on Exhibits "A" and "B" attached hereto and incorporated herein.

The PURPOSE of acquiring the Conservation Easement is to support the environmental value of wildlife habitat, open space, and productive farmland and agricultural activities that are consistent with the preservation and protection of the migratory activities of the federally protected California Tiger Salamander.
