Recommended Actions:

Adopt a CEO/Human Resources Personnel Resolution to delete one (1.0) FTE Sheriff's Deputy Trainee/Sheriff's Deputy position (Class 6904-6905; Range 5572-5972; \$3,907-\$5,822) and add one (1.0) FTE Sheriff's Deputy, Special Duty (Class 6906, Range 6072; \$5013-6120) to the Sheriff's Department.

Summary Text:

The Sheriff's Department provides the City of Goleta law enforcement services. Included in this contract is a four person Traffic Bureau. The current composition of this unit is one Sergeant and 3 Deputy Sheriffs. The City of Goleta has expressed an interest to convert one of the Deputy Sheriff positions to a Deputy Sheriff, Special Duty to allow for enhanced supervision. The cost impact for this add – delete of the position is about \$6,000, or a 5% increase in cost for the one Deputy Sheriff position. The City of Goleta will pay the increased cost.

Background:

The City of Goleta wants to ensure that there is an adequate level of supervision of its Traffic Bureau at all times. This add – delete allows the Goleta Traffic Bureau to be supervised by a Deputy Sheriff,

Special Duty in the absence of the Traffic Bureau sergeant. This will allow for enhanced supervision during the sergeants' absences for training, vacation, court appearances, etc.

Narrative:

The cost to add – delete the Deputy Sheriff position into a Deputy Sheriff, Special Duty is about \$6,000 per year. The impact of this shift in FY2007-08 is approximately \$1,500. It is recommended that a budget revision not be completed for the current fiscal year due to the small amount involved. The increased cost for future fiscal years, estimated to be about \$6,000, will be built into the contract calculations completed during the annual budget process. The revenues presented in the Recommended FY2008-09 budget include this increase in revenue and expense.
