Executive Summary and Discussion:

The Mission Canyon Sewer District (County Service Area 12) provides for wastewater collection in the Mission Canyon area of unincorporated Santa Barbara. The City of Santa Barbara, El Estero wastewater treatment plant provides wastewater treatment and disposal for CSA 12 rate payers. The county compensates the city for these services pursuant to Joint Powers Agreement No. 12,554 dated October 2, 1984. Sewer service charges are collected on the tax rolls to finance the city's costs as well as annual system maintenance, repairs, equipment depreciation and administration. This proposed action addresses the increases in city treatment and disposal costs only with no increases for the other functions mentioned above.

In addition, a minor assessment is collected by the Public Health Department to fund septic tank performance and maintenance tracking of district septic systems. The Public Health Department is not proposing any rate changes this year.

The City of Santa Barbara just completed a 10-year financial plan for their wastewater operations. The plan identified shortfalls in operating costs, the need for additional capital improvements, increases in regulatory requirements and reduced interest earnings. The city in addressing these shortfalls approved rate increases in fiscal year 2001/2002 and fiscal year 2002/2003 of 9.82% and 3.82% respectfully with no increase in fiscal year 2003/2004. The plan also calls for an additional 16% increase for fiscal year 2004/2005 with an annual rate adjustment of 4% thereafter.

Until fiscal year 2001/2002 sewer service rates were sufficient to accommodate expenditures. Last year CSA 12 generated \$217,788 in revenues for sewer services while city service charges totaled \$274,221. This reduced the CSA 12 fund balance by \$56,433, resulting in the current fund balance of \$487,846. Any further reduction to the fund balance may impede the districts ability to respond to emergencies. Therefore, staff recommends that the fund balance not be further reduced and that city of Santa Barbara rate increases (past and proposed) be passed onto the rate payers.

Current rates are \$276 annually per connection (\$23.00/month). In order to match city costs (including the 2004/2005 increase), rates need to be increased to \$404 annually per connection (\$33.67/month), an increase of \$128/year or \$10.36/month. Future adjustments for treatment and disposal services will be based on the action taken by the city in following their financial plan.

Sewer charges are generally billed on the tax rolls pursuant to Ordinance No. 3574 adopted by board on June 23, 1986. Article IV, Section 22A-35 states "all charges for annual costs of providing public sewer service and septic tank maintenance not recovered through connection charges may be collected on the tax roll, in the same manner and at the same time as the county general ad volerum property taxes are collected."

Section 22-A36 and 37 of the Ordinance also states "the Board of Supervisors shall cause to prepare a written report which shall contain a description of each parcel of real property in County Service Area 12 and the amount to be charged each parcel."

Mandates and Service Levels:

No change in programs or service level is proposed for County Service Area 12 (Mission Canyon Sewer District) with this action.

Fiscal and Facilities Impacts:

An increase to the current annual sewer service charge to \$404.00 per single family dwelling connection will generate the amount of revenue required to match proposed city costs for fiscal year 2004/2005.

WHEREAS, the Board of Supervisors of the County of Santa Barbara has heretofore established County Service Area No. 12 in the Mission Canyon Area of the unincorporated territory of the County to operate and maintain the public community sewer systems in that portion of County Service Area No. 12 where hook-ups to a community public system were required on or before September 1, 1987, and further to administer requirements for installation and use of private wastewater disposal systems in those portions of County Service Area No. 12 where such private systems now or hereafter are permitted and required; and

WHEREAS, the Board of Supervisors of the County of Santa Barbara has heretofore adopted Ordinance No. 3574, which among other things, establishes procedures for collecting various charges for the services to be rendered by County Service Area No. 12, in accordance with Government Code Sections 25210.77a through 25210.77f, and provides for periodic setting of the amount of such charges to cover the actual cost of services rendered, by Resolution of the Board of Supervisors; and

WHEREAS, such services include providing for wastewater collection, treatment and disposal; connection of building sewer to the public community sewer system, and inspection, monitoring and administering requirements for use of private wastewater disposal systems: and

WHEREAS, on May 18, 2004, a report under Chapter 22A of the Santa Barbara County Code was filed with the Clerk of the Board listing cost of said services to the County, and setting the amount to be charged to each parcel of real property in County Service Area No. 12 for such services; and

WHEREAS, performance of said services directly benefits residents in County Service Area No. 12, at costs direct and indirect, to the County of Santa Barbara for which the County should be reimbursed; and

WHEREAS, a Public Hearing on the said report relating to proposed assessments within the County Service Area No. 12 was set for the 1st day of June 2004, in the Supervisors Hearing Room, Fourth Floor, County Administration Building, Santa Barbara, California, and notice thereof published pursuant to Government Code Section 6066.

NOW, THEREFORE, IT IS RESOLVED AS FOLLOWS:

- 1. The charges for sewer service, including maintenance operation in County Service Area No. 12, for the Fiscal Year 2004/2005 shall be FOUR HUNDRED FOUR (\$404.00) annually (\$33.67 per month) for each residential dwelling unit, and FOUR HUNDRED FOUR (\$404.00) annually (\$33.67 per month) for each dwelling equivalent (as the same are established pursuant to that certain "Joint Powers Agreement for Wastewater Collection, Treatment and Disposal in the Mission Canyon Area", between the County of Santa Barbara and the City of Santa Barbara).
- 2. The charges for connection of a building sewer to the sewer in County Service Area No. 12 for the 2004/2005 fiscal year shall be FIVE THOUSAND SIX HUNDRED THIRTY-THREE DOLLARS (\$5,633.00) for each dwelling unit or dwelling unit equivalent. In no event shall this charge be made where a sewer connection charge has already been paid.
- 3. The charges for inspection, monitoring and administration of requirements for users of private wastewater disposal systems in County Service Area No. 12 for the 2004/2005 fiscal year shall be TWO DOLLARS (\$2.00) per month for each dwelling unit equivalent.
- 4. The charges for connection of a building sewer outside the public sewer service area for sewer in County Service Area No. 12 for the 2004/2005 fiscal year shall be ONE THOUSAND SIX HUNDRED FIFTY DOLLARS (\$1,650.00).

5.	The charges for administration, review, investigation, notice and hearing regarding parcels for		
which owners	have failed or refused to make conne	ection in compliance with the rules, regulations and	
requirements applicable, shall be SEVEN HUNDRED SIXTY DOLLARS (\$760.00).
