SUBJECT: No Parking Zone on Burton Mesa Boulevard in the Third Supervisorial District.

RECOMMENDATIONS:

That the Board of Supervisors adopt a resolution establishing a no parking zone on Burton Mesa Boulevard in the Vandenberg Village area.

ALIGNMENT WITH BOARD STRATEGIC PLAN:

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure.

EXECUTIVE SUMMARY & DISCUSSION:

Burton Mesa Boulevard is a three lane arterial road with bike lanes and on street parking in the Vandenberg Village area. A request was received by the Public Works Department for a no parking zone on a segment of this road adjacent to a driveway which serves an apartment complex. The driveway is located on the west side of Burton Mesa Boulevard approximately 80 feet north of the State Route 1 northbound on-ramp.

The Public Works Traffic Section staff has determined that 25 feet of no parking is needed to the south of the driveway to allow for adequate sight distance, and has prepared the attached resolution to establish a no parking zone at the following location:

On the west side of Burton Mesa Boulevard from a point 315 feet south of the centerline of Mesa Circle Drive (south) to a point 340 feet south of the centerline of Mesa Circle Drive (south).
