WHEREAS, Diane Koenig-Martinez received her Bachelor's Degree in Ergonomics from the University of California, Santa Barbara in 1983; and made Santa Barbara County her home; and

WHEREAS, Officer Koenig-Martinez entered public service in 1984 as a Group Counselor I, for the Santa Barbara County Probation Department, at the Santa Barbara Juvenile Hall and Los Prietos Boys Camp; and has served as a Deputy Probation Officer I, II and III, serving Lompoc and Santa Maria; and was promoted to Supervising Probation Officer in 2000, serving Santa Maria and Santa Barbara in both the Adult and Juvenile divisions; and

WHEREAS, Officer Koenig-Martinez was assigned in 1997 to the first Collections Unit, encouraging probationers to be fiscally responsible through the collection of fines, fees and restitution for victims; and was later assigned to the Intensive Field Supervision Unit; and served at the Camino Segundo Counseling and Education Center, working in a collaborative milieu alongside County Mental Health and Education staff to assist Court wards in a supervised educational setting. During this time she was also appointed to the Employees' University Governing Council and worked as a State Certified Trainer aiding in the development of staff; and

WHEREAS, Officer Koenig-Martinez has humbly served as a Supervisor for the Adult Supervision Unit, Juvenile Court Services Unit and the Adult Court Services Unit, encouraging staff to learn and grow in a challenging but rewarding career. She is commended for her faithful and dedicated services to the people who work and live in Santa Barbara County. Diane is looking forward to spending more time with her husband Sergio Sr. her son, Sergio Jr. and her daughter, Jacqueline.

NOW, THEREFORE, IT IS HEREBY ORDERED AND RESOLVED that the Board of Supervisors does hereby commend Supervising Probation Officer Diane Koenig-Martinez upon her retirement, for over 30 years of dedicated service to the citizens of Santa Barbara County, and to the Probation Department.
