#### **Recommendations:**

That the Board of Supervisors:

- A. Approves plans and specifications for the construction of Cathedral Oaks Road Sound Wall from 645 feet west of Placer Drive to Placer Drive in the City of Goleta, California;
- B. Award the construction contract in the amount of \$269,050.00 to the lowest responsible bidder, Parsans Construction (not a local vendor) 3334 Barnes Circle, Glendale CA., subject to the provision of documents and certification as set forth in the plans and specifications applicable to the project as required under California Law;
- C. Authorize the chair to execute the construction contract upon return of the Contractor's executed contract documents, and the review and approval of the County Counsel, Auditor-Controller and Risk Manager or their authorized representatives;
- D. Approve Contingency fund in the amount of \$25,952.50 for the construction of Cathedral Oaks Road Sound Wall in the City of Goleta, California;

### **Executive Summary and Discussion:**

On Thursday, January 3, 2002, seven (7) bids were opened for the Construction of Cathedral Oaks Road Sound Wall in the City of Goleta. The lowest responsible bid was submitted by Parsans Construction Company in the amount of \$269,050.00, which is 10.40% below the Engineer's Estimate.

The project consists of the removal of an existing wall and the construction of a noise barrier on the south side of Cathedral Oaks Road from 645 feet west of Placer Drive to Placer Drive. Along with the construction of the noise barrier wall (masonry), concrete sidewalk, in front of the new masonry wall, and a handicap ramp at the southwest corner of the intersection of Placer Drive and Cathedral Oaks Road will be constructed.

The Environmental document for the construction of Cathedral Oaks from Placer Drive to Evergreen Drive studied and assessed noise impacts associated with the project. This environmental document determined that it was necessary to mitigate noise impacts to nine properties between Placer Drive and 645 feet west of Placer Drive that back Cathedral Oaks Road. The noise barrier was designed to ensure adequate mitigation and was modified to be acceptable to the property owners.

#### **Mandates and Service Levels:**

Direction by the Board of Supervisors will not change the programs or service levels.

## **Fiscal and Facilities Impacts:**

The construction of the sound wall as part of the Cathedral Oaks Road Segment 3 has been included in the 2001/02 Budget, Fund 0015, Budget Unit 054, Account 7510, Program 2900, Org. Unit 0001. The construction project is funded with transportation impact fees.
