We are writing to urge you to reject the CCC's demands. There is no basis in the Coastal Act of our Local Coastal plan to prohibit or restrict private beach owners from access to the beach from their properties or to impose additional setbacks for beachfront properties. We reside at 3099 Padaro Lane and there are two places where the public can access the Padaro Lane beach: one at Loon Point and the other at Santa Claus Beach. This works well. Santa Barbara County has been one of the most protective of its resources and growth patterns. There is no justification for allowing the CCC to assume any additional authority to control local decision making and arbitrarily take private property rights.

Dear S.B. County Supervisors,

The Santa Barbara Urban Creeks Council is a 501(c)3 non profit that has worked for more than 20 years protecting watershed resources throughout the region. Over that time we have been a voice for the concerns of over 3000 families on the south coast of Santa Barbara County. We wish to express our support for the need to comply with the Coastal Act to better protect creeks and coastal wetlands. We urge that you not reject the Coastal Commission's suggested modifications, but to continue to work with interested parties and CCC staff to find an acceptable solution the CCC can certify as consistent with the Coastal Act.

Central to our concerns is that weakening of regulatory control of grading activity will bring irreparable harm to the region's important coastal resources. Exemptions should be carefully crafted to avoid and minimize damage to irreplaceable natural resources. Please protect fragile habitat remnants and please avoid sedimentation of creeks and estuaries caused by ag expansion and grading, by ensuring that adequate controls are in place. Over 95 percent of our coastal wetlands have already been lost. We urge you to comply with the Coastal Act and to allow the Coastal Commission's modifications to protect what remains. That is why it is overwhelmingly supported by the public. Quite simply, it protects our environment and our community, and the County Code should comply.

The Coastal Commission is giving the County a chance to work out a solution. Please take this opportunity to come up with a solution that most stakeholders can support and the Commission can certify.
