Recommended Actions:

That the Board of Supervisors:

- A. Approve and authorize the Chair to adopt a Resolution establishing: a 45 minute parking zone on Seville Road; in the Isla Vista area, Third Supervisorial District and
- B. Approve the filing of a Notice of Exemption pursuant to California Environmental Quality Act (CEQA) Guidelines Section 15301 (c), pertaining to maintenance and operation of existing facilities, for this project.

Summary Text:

Parking restrictions are either established or rescinded based on safety, necessity, and the affect on the community as a whole. The Public Works Department weighs all of these factors, and presents any recommended changes to the Board of Supervisors for approval. Proposed parking restrictions may include no parking, time limited parking, loading zones, vehicle height restricted parking, angle parking, handicapped parking, or any combination of these restrictions.

The Public Works Department has prepared the attached Resolution establishing parking restrictions at the following location:

ADOPT

45-Minute Parking Zone

- On the south side of Seville Road, between a point 140 feet west of the centerline of Embarcadero Del Mar, and a point 250 feet west of the centerline of Embarcadero Del Mar between the hours of 9:00 a.m. and 6:00 p.m. except holidays and Sundays.

Background:

The Public Works Department received a request from the Isla Vista Food Co-op regarding the curb in front of their building and the ongoing problem with vehicles being parked all day. Due to recent improvements to the Isla Vista Food Co-op, they were required to create a handicapped parking space to comply with the American Disabilities Act, thus eliminating two of their existing standard parking spaces.

Installing a time limited parking restriction at this location would enable the Food Co-op to better accommodate parking demand for its patrons. Public Works is recommending that the Board adopt the attached Resolution to create a 45 minute time limited parking restriction in front of the Food Co-op on a portion of Seville Road as identified.
