Title: Behavioral Wellness - Alcohol and Drug Programs Fund Unanticipated County General Funds

Budget Action: Increase Appropriations of \$160,000 in the Behavioral Wellness Department, Alcohol and Drug Programs (ADP) Fund, for Salaries and Benefits (\$17,000),

Services and Supplies (\$143,000), funded by an Operating Transfer from the General Fund (\$160,000). Increase appropriations of \$160,000 in General

County Programs, General Fund for Other Financing Uses funded by release of Committed Props 215/64 - Cannabis Fund Balance.

Justification: As part of the FY 2021-22 budget, the Board of Supervisors approved an ongoing set-aside of \$160,000 in General County Programs for the purpose of

enhancing cannabis education efforts for youth in Santa Barbara County. In response, the Behavioral Wellness Department, in collaboration with the Public Health Department, designed a cannabis education and prevention program that targets youth and perinatal women throughout the county and delivers services through community-based organizations. Addressing and combatting cannabis use among youth is currently one of the four priorities within the

Behavioral Wellness Department's current Strategic Prevention Plan.
