**AMENDMENT NO. 1 TO THE
AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR WITH WALLACE GROUP
(BC NO. 17-156)**

Pursuant to Paragraph 25 of the Agreement for Services of Independent Contractor (hereinafter AGREEMENT) entered into on September 13, 2016, as BC No.17-156, between the Santa Barbara County Flood Control and Water Conservation District (hereafter COUNTY), and **Wallace Group**, having its principal place of business at 612 Clarion Court, San Luis Obispo, California 93401 (hereafter CONTRACTOR), the COUNTY and CONTRACTOR amend the AGREEMENT as follows:

1. Paragraph 4 of the AGREEMENT is amended to read:

TERM. CONTRACTOR shall commence performance on September 13, 2016 and end performance upon completion, but no later than December 31, 2019 unless otherwise directed by COUNTY or unless earlier terminated.

2. Exhibit B, paragraph A is hereby amended to read:

A. For CONTRACTOR services to be rendered under this Agreement, CONTRACTOR shall be paid a total contract amount, including cost reimbursements, not to exceed **\$200,000.**

In all other respects, the AGREEMENT remains unchanged and in full effect.


