The final budget document contains the required State Controller schedules. The County Budget Act, as presented in Government Code Sections 29005 and 30200, outlines the State Controller forms and miscellaneous schedules necessary for conformity among California counties. This document sets forth appropriations adopted by your board for each departmental budget unit and fund for the fiscal year. **Background:** Previously, on November 21, 2006, the Board accepted for filing the Santa Barbara County Final Budget for Fiscal Year 2006-07. Subsequent to the filing, an accounting adjustment (as requested by the outside auditors) to the fund balance of the Department of Social Services fund was made. The accounting adjustment was a reservation of \$2.2 million for a fiscal year-end 2005-06 prepayment of benefits; at the first of the 2006-07 fiscal year the prepayment and reservation were released. The adjustment was a timing difference only; there was no net effect on the fund's budget for 2006-07. The only change in the revised Final Budget schedules is for this fund's adjusted fund balance.
