

AMENDMENT TO AGREEMENT FOR THE PROVISION OF INTEGRATED SOLID  
WASTE MANAGEMENT SERVICES BETWEEN THE CITY OF SOLVANG AND  
COUNTY OF SANTA BARBARA

This Amendment (“AMENDMENT”) modifies the attached CONTRACT effective October 13, 2003, between the City of Solvang (“CITY”) and County of Santa Barbara (“COUNTY”) as follows:

**Recitals**

- A. The CITY and COUNTY entered an agreement for the COUNTY to provide select solid waste Community Program and Regional Planning Services to the CITY and its citizens; and
- B. The COUNTY also contracts for the processing of all commingled recyclables collected by the CITY’s solid waste collector; and
- C. The CITY has requested that they share in the costs and revenues associated with the processing, and marketing of the commingled recyclables originating from the City of Solvang; and
- D. The COUNTY is willing to share in the costs and revenues associated with this program, upon the terms and conditions hereinafter set forth.

**Terms and Conditions**

1. **COST OF PROGRAM SERVICES TO BE PAID BY CITY OF SOLVANG.**

The following paragraph will replace the first paragraph of this section entitled “Program Fees”:

“In lieu of Program Fees, beginning October 1, 2008, net return from the processing and sale of the recyclable materials collected in the City of Solvang and processed by the County contractor will be retained by the County to cover the cost of providing the community program and regional planning services proscribed in this agreement as well as the administration of the recyclables processing contract.

2. **TERM OF CONTRACT.** The provision under this heading will be replaced with the following:

“COUNTY shall provide solid waste community program services to the CITY under this Agreement commencing on October 13, 2003, and shall continue until the Agreement is canceled by either party. If either the CITY or COUNTY wish to cancel or amend said Agreement, an 18-month advance notice shall be presented to the other entity.”

**3. ALL OTHER CONTRACT TERMS REMAIN THE SAME.**

IN WITNESS WHEREOF, the parties have executed this Agreement to be effective on the date executed by CITY.
