Review and approve the Statement of Final Quantities for work performed and materials supplied for this project by the Contractor, Valley Slurry Seal Company (not a local vendor), P.O. Box 981330, West Sacramento, California 95798, in the amount of \$1,146,181.95.

Summary Text:

As part of the County's annual Pavement Preservation Program, this project consisted of the application of a preventive slurry seal coat on the existing pavement surface at various locations throughout Santa Barbara County. A Slurry Seal is aggregate mixed with asphalt emulsion which is then spread onto the road pavement to provide a wearing course and to seal cracks that begin to appear 4 to 5 years after an overlay. The Slurry Seal extends the life of the pavement 5 years or more. Approximately 68 lane miles of County maintained roadway, and approximately 5.4 miles of Class I bike paths were resurfaced with the construction of this project.

The Director of Public Works accepted this project as complete on January 22, 2007. The project was completed on time and on budget.
