**WHEREAS**, Caltrans annually provides funds from the State Highway Account to award grants to cities and counties to fund coordinated transportation and land use planning projects that encourage community involvement and partnerships between the public, private organizations, and local and state agencies; and

**WHEREAS**, in August 2012, Caltrans awarded two Transportation Planning grants to Planning and Development, Long Range Planning Division; and

**WHEREAS**, adopted procedures, established by Caltrans, require the Applicant to state by resolution that the Director of Planning and Development is authorized to execute all contract agreements with Caltrans for completion of the grants for the Mission Park to Mission Canyon Road Multimodal Improvements Project and the Los Alamos Pedestrian Circulation and Parking Plan; and

**WHEREAS**, certain program conditions must be fulfilled in order to develop a Fund Transfer Agreement (contract) between Planning and Development and Caltrans; and

**NOW, THEREFORE, IT IS HEREBY RESOLVED**, that the County of Santa Barbara Board of Supervisors:

Authorizes the Director of Planning and Development to execute all contract agreements with Caltrans for the completion of the grants for the two aforementioned projects.
