**Summary:**

Elections Code Sections 15372 and 15400 mandates that the Registrar of Voters complete an official canvass of the election and submit the results to the governing body within 28 days. The canvass was completed on June 4, 2009.

As required by Election Code Section 15372, a signed and sealed Certificate of Election Results of the Official Canvass (Attachment A) and an Official Election Summary is attached (Attachment B).

With the certification of the election results by the Registrar of Voters, the final date for any registered voter in Santa Barbara County to request a recount of the results of this election is June 9, 2009 (Elections Code Section 15620).
