**AMENDMENT NO. 1 TO THE
AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR WITH
BOB'S BACKHOE & TRUCKING
(Trucking Services, BC NO. 21-023)**

Pursuant to Paragraph 31 of the Agreement for Services of Independent Contractor (hereinafter AGREEMENT) entered into on July 1, 2021 as BC No. 21-023, between the **Santa Barbara County Flood Control and Water Conservation District** (hereafter COUNTY), and **Bob's Backhoe & Trucking** having its principal place of business at 5775 Thornwood Drive, Goleta, CA 93117 (hereafter CONTRACTOR), the COUNTY and CONTRACTOR amend the AGREEMENT as follows:

- 1. **Attachment B1, paragraph titled Potential Rate and Adjustment Based on Fuel Price is hereby amended to read:**

During the life of this agreement, the County will adjust the hourly rate for trucking services due to changes in the fuel cost. If the cost of fuel increases or decreases more than 15% of the price of fuel on July 1, 2021, the County will adjust the hourly rate by 4% accordingly. Furthermore, the rates will be adjusted 4% for each incremental change of 15% in fuel prices. The County will use the U.S. Energy Information Administration Monthly Retail Gasoline and Diesel Prices for California to determine fuel costs. The adjustment rate is less than the change of fuel cost since fuel is only one factor in the cost of providing trucking services.

In all other respects, the AGREEMENT remains unchanged and in full effect.


