IN THE MATTER OF APPROVING AN AMENDMENT TO THE COUNTY OF SANTA BARBARA LOCAL COASTAL PROGRAM, INCLUDING ARTICLE II, THE COASTAL ZONING ORDINANCE, OF CHAPTER 35, ZONING, OF THE SANTA BARBARA COUNTY CODE, REGARDING STREAMLINED PERMIT PROCESSING, AS MODIFIED BY THE CALIFORNIA COASTAL COMMISSION.

WHEREAS, on December 3, 2024, the Board adopted Ordinance No. 5222 (Case No. 24ORD-00010) amending the text of Article II, the Coastal Zoning Ordinance, to comply with changes to state law regarding streamlined permit processing in accordance with SB 35, SB 423, and AB 3122.

WHEREAS, on December 3, 2024, the Board adopted Resolution No. 24-267 authorizing the Planning and Development Department to submit the above amendment (Ordinance No. 5222) to the California Coastal Commission (Coastal Commission) as a Local Coastal Program amendment for review and certification;

WHEREAS, on March 11, 2026, the Coastal Commission approved a resolution of conditional certification with suggested modifications to Ordinance No. 5222, the County's Local Coastal Program amendment (Coastal Commission Case No. LCP-4-STB-24-0064-2 (SB 35/423)); and

WHEREAS, the Board finds the Coastal Commission's suggested modifications to be acceptable and consistent with the intent of the County's Local Coastal Program amendment.

NOW, THEREFORE, IT IS HEREBY RESOLVED as follows:

1. The above recitations are true and correct.
2. The Board acknowledges receipt of the Coastal Commission's resolution of conditional certification with suggested modifications for Ordinance No. 5222, and accepts and agrees to the modifications through an amendment to the County's certified Local Coastal Program as required by Coastal Commission Administrative Regulation Section 13544(a), and agrees to issue Coastal Development Permits for the total area included in the County's certified Local Coastal Program, consistent with the Coastal Commission's certified suggested modifications to Ordinance No. 5222.
3. The Board will submit this acknowledgment to the Coastal Commission to demonstrate conformity with the provisions of the Coastal Commission's action to certify the County's Local Coastal Program amendment in compliance with Coastal Commission Administrative Regulation Section 13544(b).
